1. Rationale

Oakleigh Grammar is committed to protecting the privacy of individuals.

The school therefore support and endorse the Australian Privacy Principles ("APPs") contained in the Privacy Act 1988 (Cth) ("the Privacy Act") and will only collect, use, disclose, manage and store personal information in accordance with these principles.

The school will also comply with the requirements of the *Health Records Act 2001 (Vic)*.

2. Aim

Oakleigh Grammar is required under the Privacy Act to have a clearly expressed and up-to-date privacy policy about how the school manages personal information.

This policy outlines how Oakleigh Grammar will comply with its obligations under the Privacy Act.

3. Scope

This policy outlines the circumstances in which we obtain personal information, how we use and disclose that information, and how we manage requests to access and/or change that information.

4. Definitions

In the course of providing services and depending on the circumstances, the school may collect personal information from the individual in their capacity as a student, contractor, volunteer, stakeholder, job applicant, alumni, visitor or others that come into contact with the school.

Personal/information means information or an opinion about an identified individual, or an individual who is reasonably identifiable:

- whether the information or opinion is true or not; and
- whether the information or opinion is recorded in a material form or not.

In the course of providing services we may collect and hold personal information including names, addresses and other contact details; dates of birth; next of kin details; photographic ID images; attendance records and financial information.

Sensitive information includes information or an opinion about an individual's:

- racial or ethnic origin
- political opinions
- membership of a political association
- religious beliefs or affiliations
- philosophical beliefs
- professional memberships
- government identifiers (such as TFN)
- sexual orientation or practices
- court orders
- criminal record, that is also personal information.

Health information (particularly in relation to prospective staff and student records) includes information or an opinion about an individual:

- health information including medical records, disabilities, immunisation details and psychological reports
- genetic information about an individual that is not otherwise health information
- biometric information that is to be used for the purpose of automated biometric verification or biometric identification, or
- biometric templates.

Generally, we will seek consent from the individual in writing before we collect any sensitive or health information.

It is noted that employee records are not covered by the APPs or the Health Privacy Principles where they relate to current or former employment relations between the school and the employee.

Please note: However, a current or former employee's health records are covered by the Victorian Health Privacy Principles.

5. What Kind of Information Does Oakleigh Grammar Collect?

The School collects and holds Personal Information about:

- Students and Parents before, during and after the course of a student's enrolment at the School;
- Job applicants, staff members, volunteers and contractors; and
- Other people who come into contact with the School.

The type of information that the school collects and holds (refer to all Definitions) will depend on the circumstances in which the school is collecting it. The information collected may include but not be limited to name, address and other contact details, date of birth, financial information, citizenship, employment references, current employment information, directorships, media, photo id information, bank account details, driver's licence information, academic results and qualifications.

The school may also collect sensitive information from a person including health information.

A person is not required to provide the personal information and/or sensitive information requested by the school, however if a person chooses not to provide information as requested, this may influence the school's ability to service the person's needs. For instance, it will not be possible for the school to enrol a person or provide education to the person if the person wishes to remain anonymous or use a pseudonym.

6. How Does Oakleigh Grammar Collect Personal Information?

The school will generally collect personal information directly from the owner in the following manner:

a) Solicited Information

The school has, where possible, attempted to standardise the collection of personal information by using specifically designed forms (e.g. an Enrolment Form or Medical Information Disclosure Form). However, given the nature of our operations we also receive personal information by email, letters, notes, via our website, Student Management System Compass, over the telephone, in face-to-face meetings, through financial transactions, donations, fee payments and through surveillance activities such as the use of CCTV security cameras or email monitoring.

We may also collect personal information from other people (e.g. a third-party administrator, referees for prospective employees) or independent sources. However, we will only do so where it is not reasonable and practical to collect the personal information from the individual directly.

We may collect information based on how individuals use our website. We use "cookies" and other data collection methods to collect information on website activity such as the number of visitors, the number of pages viewed and the internet advertisements which bring visitors to our website. This information is collected to analyse and improve our website, marketing campaigns and to record statistics on web traffic. We do not use this information to personally identify individuals.

On occasion, the school may collect personal information from a third party. For example, personal information may be provided to the school by a health report provided by a medical professional or court orders.

The school will generally obtain consent from the owner of personal information to collect their personal information. Consent will usually be provided in writing however sometimes it may be provided orally or may be implied through a person's conduct.

The school will endeavour to only ask a person for personal information that is reasonably necessary for the activities that the person is seeking to be involved in.

b) Unsolicited Information

The school may be provided with personal information without having sought it through our normal means of collection. This is known as "unsolicited information" and is often collected by:

- Misdirected postal mail - letters, notes, documents
- Misdirected electronic mail - Emails, electronic messages
- Employment applications sent to us that are not in response to an advertised vacancy
- Additional information provided to us which was not requested.

Unsolicited information obtained by the school will only be held, used and/or disclosed if it is considered as personal information that could have been collected by normal means. If that unsolicited information could not have been collected by normal means then we will destroy, permanently delete or de-identify the personal information as appropriate.

7. How will Oakleigh Grammar use Personal Information?

The school only uses personal information that is reasonably necessary for one or more of our functions or activities (the primary purpose) or for a related secondary purpose that would be reasonably expected by you, or for an activity or purpose to which you have consented.

The school may collect, hold, use or disclose a person's personal information for the following general purposes:

- to identify a person;
- for the purpose for which the personal information was originally collected;
- for a purpose for which a person has consented;
- for any other purpose authorised or required by an Australian law; and
- for any other purpose authorised or required by a court or tribunal.

More specifically the school may collect, hold, use or disclose a person's personal information for the following purposes:

a. Students and Parents/Guardians

The Privacy Act does not differentiate between adults and children and does not specify an age after which individuals can make their own decisions with respect to their personal information.

At Oakleigh Grammar we exercise judgement, in dealing with a student's personal information and generally will refer any requests for personal information to a student's parents and/or guardians. We will treat notices provided to parents and/or guardians as notices provided to students and we will treat consents provided by parents and/or guardians as consents provided by a student.

In relation to the personal information of students and parents and/or guardians, the school's primary purpose of collecting the personal information is to enable the school to provide education, pastoral care, extra-curricular and health services to the student.

For example, the school uses personal information of students and parents and/or guardians for:

- correspondence with parents and/or guardians to keep parents and/or guardians informed about matters related to their child's performance at school;
- publication of newsletters and articles on our website;
- day-to-day administration;
- looking after a student's educational, social and medical wellbeing;
- the collection of debts owed to the school; and

- seeking donations and other fundraising activities for the school.

The school may publish the contact details of parents and/or guardians in a class list and publish photos of students and parents and/or guardians in publications.

If a person has any concerns about their personal information being used by the school in any of these ways, the person must notify the school.

b. Staff members, Contractors and Volunteers

In relation to the personal information of prospective and current staff members, contractors and volunteers, the school may use personal information to:

- enable the school to carry out its recruitment functions;
- correspond with the person, provide training and professional development;
- fulfil the terms of any contractual relationship; and
- ensure that the person can perform their duties to facilitate the education of the students.

The school may publish the photographs of staff, contractors and volunteers in publications.

If a person has any concerns about their personal information being used by the school in any of these ways, the person must notify the school.

The school will take all reasonable steps to ensure the personal information we hold, use and disclose is accurate, complete and up-to-date, including at the time of using or disclosing the information. If the school becomes aware that the personal information is incorrect or out of date, we will take reasonable steps to rectify the incorrect or out of date information.

8. Who May Oakleigh Grammar Disclose Personal Information to?

The school may disclose a person's personal information, including sensitive information, to:

- government departments;
- courts
- health practitioners;
- recipients of school publications; and
- anyone the school is authorised to disclose personal information to

The school may also disclose a person's personal information to another organisation with the person's consent.

The school will only use or disclose sensitive or health information for a secondary purpose if you would reasonably expect us to use or disclose the information and the secondary purpose is directly related to the primary purpose.

The school may share personal information to related bodies corporate, but only if necessary for us to provide our services.

9. Disclosure of Personal Information Overseas

The school may disclose personal information to a recipient overseas (for example where we have outsourced a business activity to an overseas provider) in accordance with the Privacy Act, where we take reasonable steps to ensure that the overseas recipient does not breach the APPs in relation to the information.

Otherwise, the school may disclose personal information to a recipient overseas in accordance with the Privacy Act where:

- the owner of the personal information has consented to the disclosure;
- we reasonably believe that the overseas recipient is subject to a law or binding scheme that protects the information in a way that is substantially similar to the way the information is protected under the Privacy Act and the APPs;
- we form the opinion that the disclosure will lessen or prevent a serious threat to the life, health or safety of an individual or to public safety; or
- the disclosure is required or authorised by an Australian law or a court order.

10. Direct Marketing

Marketing and business development is important to ensure that the school continues to provide quality educational services.

The school will use a person's personal information to send marketing information including the school magazine and newsletters. Personal information held by the school may be disclosed to an organisation that assists the school with its marketing.

If a person does not want to receive any such information, the person can contact the school by email on marketing@oakleighgrammar.vic.edu.au.

Once the school receives a request to "opt out" from receiving marketing information, the school will cease sending such information.

11. How Does Oakleigh Grammar Store and Secure Personal Information?

The school stores personal information in a variety of formats including, but not limited to:

- databases
- soft copy files
- personal devices, including laptop computers
- third party storage providers such as cloud storage facilities
- paper based files.

The school takes all reasonable steps to protect personal information under its control from misuse, interference and loss and from unauthorised access, modification or disclosure.

These steps include, but are not limited to:

- restricted access and user privilege of information by staff depending on their role and responsibilities;
- storing paper records in lockable filing cabinets in lockable rooms. Staff access is subject to user privilege;
- password restricted access to computerised records;
- ensuring our IT and cyber security systems, policies and procedures are implemented and up to date;
- ensuring staff comply with internal policies and procedures when handling the information;
- implementing physical security measures around the school buildings and grounds to prevent break-ins; and
- the destruction, deletion or de-identification of personal information we hold that is no longer needed, or required to be retained by any other laws.

Our public website may contain links to other third-party websites outside of Oakleigh Grammar. The school is not responsible for the information stored, accessed, used or disclosed on such websites and we cannot comment on their privacy policies.

12. Responding to Data Breaches

Oakleigh Grammar will take appropriate, prompt action if we have reasonable grounds to believe that a data breach may have or is suspected to have occurred. Depending on the type of data breach, this may include a review of our internal security procedures, taking remedial internal action, notifying affected individuals and the Office of the Australian Information Commissioner (OAIC).

If we are unable to notify individuals, we will publish a statement on our website and take reasonable steps to publicize the contents of this statement.

13. Oakleigh Grammar Website

When a person visits the school website (<http://www.oakleighgrammar.vic.edu.au>), the school's server or internet service provider records for statistical purposes the following in relation to each visit to the site:

- the visitor's server address
- (which includes the top-level domain name e.g. com.gov.au)
- date and time
- pages accessed and documents downloaded
- previous site visited
- country from which the site was visited
- type of operating system used
- type of browser used.

The website uses cookies.

Oakleigh Grammar may at times use an external company to understand our users' needs and to improve our website service and experience.

Any external company we use will be a technology service that helps Oakleigh Grammar to gain insight into our users' experience (e.g. how much time they spend on which pages, the specific links they choose to click, what users do and don't like, etc.) and this enables us to optimise our website service via the integration of user feedback. They will use cookies and other technologies to collect data on our users' behaviour and their devices, in particular - device's IP address (captured and stored only in anonymized form), device screen size, device type (unique device identifiers), browser information, geographic location (country only), preferred language used to display our website. An external company may store this information in a pseudonymised user profile. Neither the external company nor Oakleigh Grammar will ever use this information to identify individual users or to match it with further data on an individual user's creation of a user profile.

The school will only record personal information supplied via the website including email addresses if sent a message or if a customer has voluntarily supplied it as part of an online payment transaction or via an online supply of information to the school.

14. How can a Person Update Their Personal Information?

The school is committed to holding accurate and up-to-date personal information.

A person may contact Oakleigh Grammar at any time to update their personal information held by the school either via the Compass portal, email or phone.

The school will destroy or de-identify any personal information which is no longer required by the school for any purpose for which the school may use or disclose it, unless the school is required by law or under an Australian law or a court order to retain it.

15. How can a person Access Personal Information?

If an individual wishes to access personal information held about themselves or about a student for which they are a parent or guardian in order to seek correction of such information they may do so by contacting the Admissions Officer in writing via email: admissions@oakleighgrammar.vic.edu.au.

In accordance with the Privacy Act, the school may refuse access to personal information in a number of circumstances including where giving access to the information would pose a serious threat to the life, health or safety of a person, giving access would have an unreasonable impact on the privacy of a person, the information relates to existing or anticipated legal proceedings with you and would not be available under the discovery process, or denying access is required or authorised by an Australian law or court order.

The school will seek to handle all requests for access to personal information as quickly as possible.

16. Complaints

Complaints about a breach of the APPs must be made in writing to the Admissions Officer: admissions@oakleighgrammar.vic.edu.au. The school will investigate any complaint and will notify you, in writing, of any decision in relation to your complaint as soon as practicable.

If a complainant is not satisfied with the response they can refer the complaint to the Office of the Australian Information Commissioner (OAIC). A complaint can be made using the OAIC online Privacy Complaint form or by mail, fax or email. A referral to OAIC should be a last resort once all other avenues of resolution have been exhausted.
